Guideline for Contributing to the Transactions of the Japan Society for Aeronautical and Space Sciences

1. The Transactions of the Japan Society for Aeronautical and Space Sciences is a bimonthly online journal published in English. The journal considers submissions from researchers from around the world who investigate any area of the aeronautical and space sciences. Topics may include, but are not limited to aerodynamics, aircraft design, aerospace structures and materials, flight dynamics, aerospace control and guidance systems, air traffic management, astrodynamics, and aerospace propulsion. The journal encourages submissions that take both theoretical, basic and applied approaches to the important issues in the field.

The journal is fully Open Access and uses Creative Commons (CC) licenses, which allow users to use, reuse and build upon the material published in the journal without charge or the need to ask prior permission from the publisher or author.

- 2. All articles shall be fully peer-reviewed and shall make original and important contributions to aeronautical and space science. The journal follows ethical standards in publication. The journal publishes Full Articles, Survey Articles, Research Notes, and Miscellaneous articles such as Comments and Questions, Replies and Errata. Our audience is diverse and global researchers, technologists and engineers, interested in discovering and reading information vital to the progress of the aeronautical and space sciences.
- 3. The articles are available online to JSASS and non-JSASS members alike, for open access and download as of the publication date. Electronic reference files including additional information (hereinafter referred to as "supplementary materials") can be attached to each article available on the Web at an additional charge (details below). Supplementary materials do not require review, but should be approved by the Editorial Board prior to publication.
- 4. Articles must be submitted using the JSASS article submission Web page; articles sent by conventional mail and e-mail will not be considered for publication. The author must provide the information required for the authors, abstract, etc., as requested on the article submission Web page, and upload a PDF file of the article.
- 5. The article must be prepared using the template available on the JSASS Web page. The author must convert the article into a 600 dpi PDF file upon submission. The maximum size of the PDF file is 5 MB.

Please be advised that the PDF file must be readable regardless of the machine used to access it, and therefore the use of any special fonts, such as Japanese fonts, for example, is not permitted.

6. Each article submitted shall be reviewed based on the review standards specified in the Appendix of this guideline, and judgment will be made as to whether or not it is suitable for publication.

7. Copyright

Copyright of articles printed in Transactions of JSASS belongs to the Japan Society for Aeronautical and Space Sciences for published articles submitted before August 31, 2021. Authors retain copyright for published articles submitted on or after September 1, 2021, but are required to sign a License to Publish to grant the JSASS permission to edit and reproduce the work in the journal under one of the licenses described in the 'Creative Commons licenses' section

7.1 Creative Commons licenses

All articles in the journal are Open Access. Authors can choose one of the following Creative Commons licenses: CC BY, CC BY-NC-ND. We recommend CC BY license which allows for maximum dissemination and re-use of open access materials and is preferred by many research funding bodies. Once selected, the terms of the Creative Commons licenses are non-revocable. It is the author's responsibility to ensure the license selected complies with their funding body's requirements.

CC BY (Attribution) license: This license lets others copy, distribute, remix, and build upon the Article, even commercially, provided the original source and Authors are credited (see http://creativecommons.org/licenses/by/4.0/).

CC BY-NC-ND (Attribution-NonCommercial-NoDerivatives) License: This license allows users to non-commercially distribute and reproduce the unmodified Article, provided the original source and Authors are credited

(see https://creativecommons.org/licenses/by-nc-nd/4.0/).

7.2 Author rights and repository policy

Authors retain copyright of their work. Authors are able to enter into separate, additional contractual arrangements for the non-exclusive distribution of the journal's published version of the work (e.g., post it to an institutional repository or publish it in a book), with an acknowledgement of its initial publication in this journal.

The contents of any article or research notes submitted for publication in a JSASS journal cannot have been previously published anywhere. Exceptions shall include articles presented, or to be presented, for the proceedings of a conference or a collection of papers organized by JSASS. It is the responsibility of the author to obtain any required government or company reviews and/or clearances of their papers prior to submission.

- 9 The contribution of comments and questions is accepted only for full articles and research notes published within six months. Authors of a full article or research notes who intend to reply to comments and questions must submit their replies within one month after they receive the comments or questions. Questions and replies will be published in the same issue. However, questions that receive no reply may be published even if the author fails to submit a reply. Comments and questions can be submitted only once by the same contributor.
- 10 Authors shall take full responsibility for the contents of their contributions.
- 11 Once an article has been accepted for publication and the author(s) informed of the decision, the authors of the article are required to pay the Article Processing Charges (APCs) indicated in the Appendix of this guideline.

3. Article Categories in Transactions of JSASS

The article categories are defined in the following table.

- † 1 A single page can contain approximately 1,200 words for articles in English. The space for the article title and authors' names requires 1/4-1/5 pages.
- † 2 Each article on the Web may include a maximum of five reference files as supplementary materials. (File size is to be less than 5 MB per file and no more than 10 MB in total.) Acceptable file format is described in the paper "Template."

4. Article Processing Charges (APCs)

The authors of all articles to be published in Transactions of JSASS must pay a APC to JSASS before the article's publication according to the first author's membership status at the time of publication. For full articles, any paper that is 16 pages or longer in length will be rejected without review. For research notes, any paper that is five pages or longer in length will be rejected without review. Please note that the reprinting service is not available. The color page fee is not applied for any articles. The APC depends on the article category and number of pages as follows:

5. Exemption

The author can request a APC exemption if, at the time of publication, they meet the following three criteria: 1) the first author is over 65 years old, 2) the first author has been continuously a member of JSASS for more than 35 years, and 3) the first author is unemployed. This exemption is applicable to one article per year. The fee for pages beyond the standard number of pages indicated in Table 1 is not exempted.
